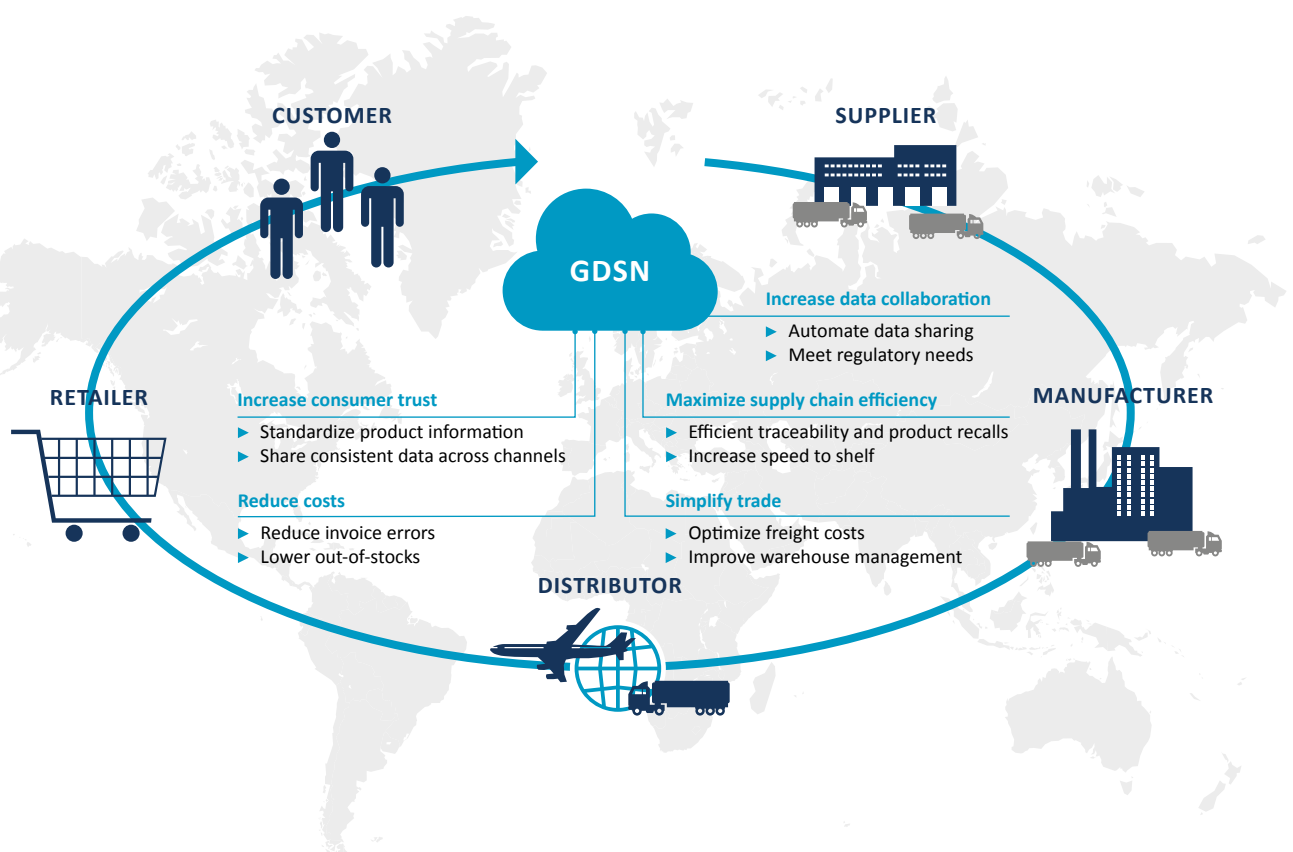

Why compliance with GDSN matters?

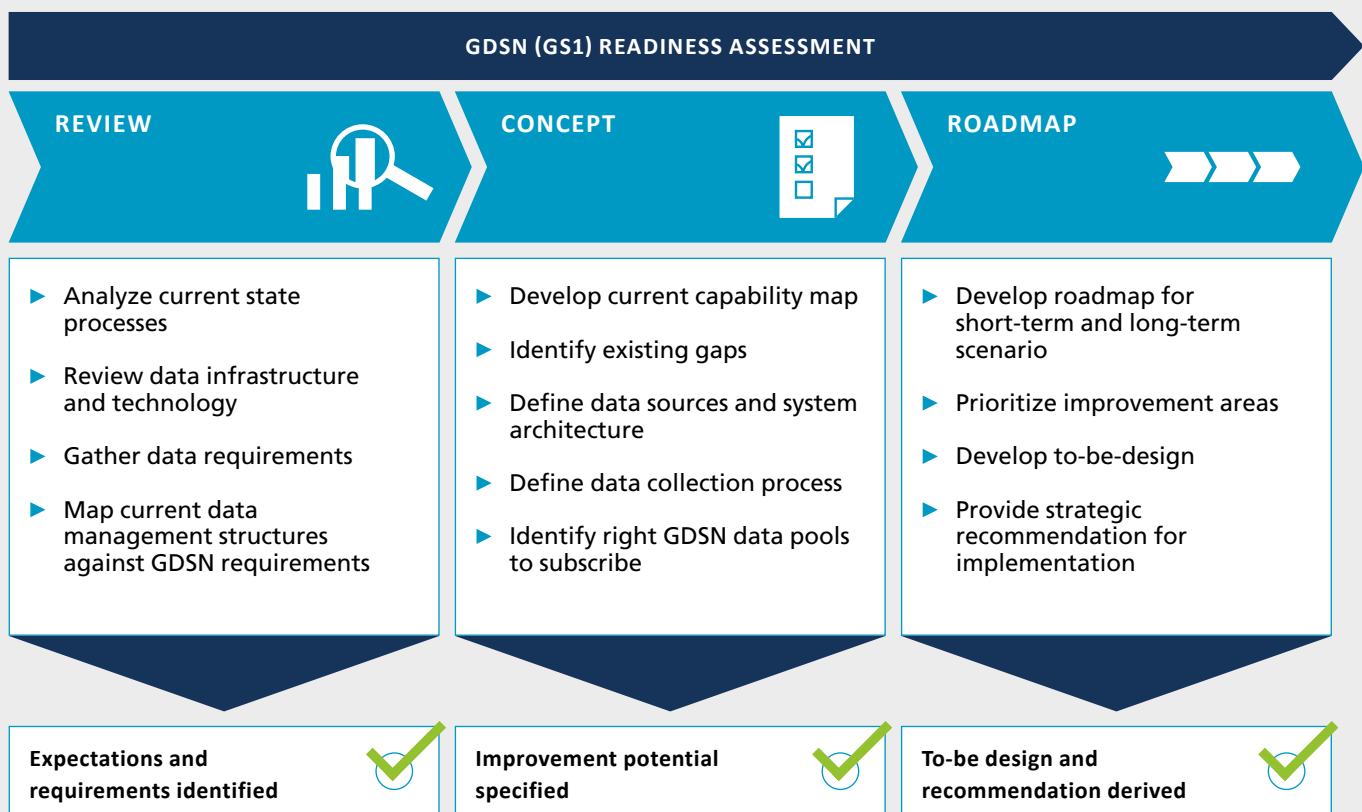
